

Weil-McLain Limited Lifetime Warranty for Residential Indirect-Fired Water Heaters

First Year—Limited Warranty for Residential Indirect-Fired Water Heaters:

Weil-McLain warrants that its residential indirect-fired water heaters are free from defects in material and workmanship for one year from date of installation. If any parts are found to be defective in manufacture during such time period, Weil-McLain will provide replacements for such defective parts.

Second Through Fifth Year—Limited Warranty for the Tank Assembly of Its Residential Indirect-Fired Water Heaters:

Weil-McLain warrants that the tank assembly component of its residential indirect-fired water heaters are free from defects in material and workmanship for the second through the fifth year following the date of installation. If, during such time period, a leak in the tank assembly should occur, Weil-McLain will provide replacement for such defective tank assembly.

Sixth Year and Beyond—Limited Lifetime Warranty for the Tank Assembly of Its Residential Indirect-Fired Water Heaters:

Weil-McLain warrants that the tank assembly component of its residential indirect-fired water heaters are free from defects in material and workmanship for the sixth year and beyond following the date of installation. If, during such time period, a leak in the tank assembly should occur, Weil-McLain will provide replacement for such defective tank assembly upon the payment of a proportionate charge based upon the time the residential indirect-fired water heater has been in service. Such replacement will be furnished with the nearest comparable model available from Weil-McLain at the time of such replacement. The proportionate charge will be equal to the appropriate percentage of the current list price of such residential indirect-fired water heaters at the time the warranty claim is made, and will be determined as follows:

6th through 7th year	— 55%	8th through 9th year	— 60%
10th through 11th year	— 65%	12th through 13th year	— 70%
14th year and beyond	— 75%		

This warranty is subject to the condition that the residential indirect-fired water heater must have been installed by a heating contractor whose principal occupation is the sale and installation of plumbing, heating and/or air conditioning equipment.

This warranty does not cover:

1. Residential indirect-fired water heaters installed in buildings other than one or two family dwelling units, unless they are buildings with individual indirect-fired water heaters for each dwelling unit.
2. Components that are part of the indirect-fired water heater system but were not furnished by Weil-McLain as part of the residential indirect-fired water heaters.
3. The workmanship of any installer of Weil-McLain's residential indirect-fired water heaters. In addition, this warranty does not assume any liability of any nature for unsatisfactory performance caused by improper installation.
4. Any costs for labor for removal and reinstallation of the alleged defective part, transportation to Weil-McLain, if necessary, and any other materials necessary to perform the exchange.
5. Any indirect-fired water heater that does not have installed a new temperature-pressure relief valve bearing the listing

of the American Society of Mechanical Engineers (A.S.M.E.) at the time of the water heater installation.

6. Any indirect-fired water heater that has a failure or malfunction resulting from improper or negligent operation, accident, abuse, freezing, misuse, unauthorized alteration or improper repair or maintenance.
7. Any indirect-fired water heater that has a failure or malfunction resulting from a) failure to keep the tank full of potable water; b) failure to assure that water in the tank is free to circulate at all times; or c) failure to keep the tank free of water sediment or scale deposits.
8. Any indirect-fired water heater that has potable water in the unit with a chloride or chlorine content higher than 80 mg/liter.
9. Any indirect-fired water heater that is installed in a residence containing any type of water softener system that is not installed and maintained in accordance with the manufacturer's specifications.
10. Any indirect-fired water heater that is installed where polybutylene pipe without an oxygen barrier is used.
11. Any indirect-fired water heater that is used for non-potable applications such as pool or process heating.

This warranty extends only to the first retail purchaser of the indirect-fired water heater and only to an indirect-fired water heater that has not been moved from its original installation site.

IMPLIED WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE AND MERCHANTABILITY SHALL BE LIMITED TO THE DURATION OF THE ONE YEAR EXPRESS WARRANTY. WEIL-McLAIN EXPRESSLY DISCLAIMS AND EXCLUDES ANY LIABILITY FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES FOR BREACH OF ANY EXPRESS OR IMPLIED WARRANTY.

First Year—Limited Warranty for Commercial Indirect-Fired Water Heaters:

Weil-McLain warrants that its commercial indirect-fired water heaters are free from defects in material and workmanship for one year from date of installation. If any parts are found to be defective in manufacture during such time period, Weil-McLain will provide replacements for such defective parts.

Second Through Fifth Year—Limited Warranty for the Tank Assembly of Its Commercial Indirect-Fired Water Heaters:

Weil-McLain warrants that the tank assembly component of its commercial indirect-fired water heaters are free from defects in material and workmanship for the second through the fifth year following the date of installation. If, during such time period, a leak in the tank assembly should occur, Weil-McLain will provide replacement for such defective tank assembly.

Sixth Year Through Fifteenth Year—Additional Limited Warranty for the Tank Assembly of Its Commercial Indirect-Fired Water Heaters:

Weil-McLain warrants that the tank assembly component of its commercial indirect-fired water heaters are free from defects in material and workmanship for the sixth year through the fifteenth year following the date of installation. If, during such time period, a leak in the tank assembly should occur, Weil-McLain will provide replacement for such defective tank assembly upon the payment of a proportionate charge based upon the time the commercial indirect-fired water heater has been in service. Such replacement will be furnished with the nearest comparable model available from Weil-McLain at the time of such replacement. The proportionate charge will be equal to the appropriate percentage of the current list price of such commercial indirect-fired water heaters at the time the warranty claim is made, and will be determined as follows:

6th through 7th year — 55% 8th through 9th year — 60%
10th through 11th year — 65% 12th through 13th year — 70%
14th through 15th year — 75%

This warranty is subject to the condition that the commercial indirect-fired water heater must have been installed by a heating contractor whose principal occupation is the sale and installation of plumbing, heating and/or air conditioning equipment.

This warranty does not cover:
