## **Program Outline & Requirements**

- Products covered include:
  - Residential & Commercial Products (except for Model 94 and HVAC Products) included in Trade Price Schedule 48.
  - Service Parts, Additional Products, Baseboard, and Water Heaters.
- ☐ Qualifying Non-VAP orders must be \$15,000 net minimum.
- ☐ Qualifying VAP orders must be \$50,000 net minimum.
- □ Orders that are <u>NOT ELIGIBLE</u> for this program include:
  - Orders for Model 94 boilers or HVAC Equipment.
  - Hold orders or orders requesting any scheduled shipments
- ☐ Eligible orders must be for <u>immediate shipment</u>. No scheduled orders allowed of any kind. Any orders or portions of orders that are not for immediate shipment will <u>NOT</u> be eligible for any Pre-Season discounts or terms.
- Distributor accounts must be current at the time of order entry to be included in program.
