Weil-McLain is pleased to announce the 2011 Pre-Season Stocking Program. The program consists of two parts including discounts and extended terms as outlined below.

Program Outline & Requirements

- Products covered include:
 - Residential & Commercial Products (except for Model 94, Ultra Commercial, and HVAC Products) included in Trade Price Schedule 49.
 - Service Parts, Additional Products, Baseboard, and Water Heaters.
- **Qualifying Non-VAP orders must be \$25,000 net minimum.**
- **Qualifying VAP orders must be \$50,000 net minimum.**
- □ Orders that are <u>NOT ELIGIBLE</u> for this program include:
 - Orders for Model 94 boilers, Commercial Ultra, or HVAC Equipment.
 - Hold orders or orders requesting any scheduled shipments
- Eligible orders must be for <u>immediate shipment</u>. No scheduled orders allowed of any kind. Any orders or portions of orders that are not for immediate shipment will <u>NOT</u> be eligible for any Pre-Season discounts or terms.
- Distributor accounts <u>must be current</u> at the time of order entry to be included in program.

- □ <u>All</u> Weil-McLain distributors can participate in this program.
- Qualifying orders are new orders entered for <u>immediate shipment only</u> from May23rd through June 10th, 2011.
- □ Identify eligible orders with the following: "MPA11-0098 " Dating Request #969.
- **Orders meeting program requirements will be eligible for the following:**

Additional 5% Rebate 60 Day Additional Terms (30+60=90)

Part 2

- □ <u>All</u> Weil-McLain distributors can participate in this program.
- Qualifying orders are new orders entered for <u>immediate shipment only</u> from June 13th through June 30th, 2011.
- □ Identify eligible orders with the following: "MPA 11-0099" Dating Request #970.
- **Orders meeting program requirements will be eligible for the following:**

Additional 4% Rebate 30 Day Additional Terms (30+30=60)

We will be announcing a price increase effective July 1, 2011. The increase will range from 4-8% depending on product. Take this opportunity to stock up prior to the increase.

Rebates will be issued at the end of August, 2011.
