

WGO / WTGO Series 3

Oil-Fired Water Boiler

ENERGY STAR[®] Supplement

This supplement is for the WGO and WTGO boilers rated for ENERGY STAR[®] compliance. The boilers listed in the following chart are in compliance with ENERGY STAR Program version 3.0 when equipped with the appropriate Field Controls Oil Vent Damper (OVD) kits listed on page 2.

This supplement needs to be used in conjunction with Boiler Manual - WGO - P/N 550-141-826 and WTGO - P/N 550-141-825.

- (4) Based on standard test procedures prescribed by the United States Department of Energy at combustion condition of 13.5% CO₂ and -0.02" W.C. draft overfire.

(5) Net AHRI ratings are based on net installed radiation of sufficient quantity for the requirements of the building and nothing need be added for normal piping and pick-up. Water ratings are based on a piping and pick-up allowance of 1.15. An additional allowance should be made for unusual piping and pick-up loads.

(6) See manual for minimum breeching diameter.

(7) Listed draft losses are for factory-shipped settings.

(8) Boiler model suffixes: "R" designates a reduced input version. "D" for damper. NOTE: A burner nozzle change is required — refer to the burner instructions or boiler's rating label for correct selection.

NOTICE When installing the damper with the WGO/WTGO boiler, place the new conversion label and energy guide labels included with the kit on the boiler. EnergyGuide labels should be placed next to the existing labels. Place conversion label as close as possible to existing rating label.

The WGO/WTGO boilers with reduced rates, when installed with the oil vent damper, comply with the guidelines of ENERGY STAR. The vent damper, kit part numbers (below), must be installed in accordance with the damper installation manual. Models WGO-2RD, WGO/WTGO-3RD, WGO/WTGO-4RD, WGO/WTGO-5RD, WGO/WTGO-6RD and WGO/WTGO-7RD are ENERGY STAR tested and certified.
